This HSE approved course totals 24 Hours and must be completed within 13 weeks. This is usually delivered over 4 days four weeks tailoring to specific needs.

- Carry out artificial ventilation and chest compressions
- Place casualty into the recovery position and know to use this position
- Clear obstructed airway
- Control severe bleeding
- Recognise and treat shock
- Understand the requirements of a first aid kit and how to report accidents in the workplace
- Recognise and treat major illnesses
- Deal with burns and scolds
- Recognise and treat fractures
- Carry out the duties of a First Aider in a safe and approved manner, with no risk to self or third party.

This is a 2 day course that can be delivered either over 2 consecutive days or one day a week over 2 weeks

- Place casualty into the recovery position and know to use this position
- Clear obstructed airway
- Control severe bleeding
- Recognise and treat shock
- Understand the requirements of a first aid kit and how to report accidents in the workplace
- Recognise and treat major illnesses
- Deal with burns and scolds
- Recognise and treat fractures
- Carry out the duties of a First-Aider in a safe and approved manner, with no risk to self or third party.

AED Defibrillator Training



Automatic External Defibrillator Course

In the UK, one person suffers a heart attack every two minutes but the majority could be saved if their heart was shocked back into rhythm.



This course teaches the essential skills required by an AED operator and gives students the confidence to know what to do in this kind of emergency. No previous first aid knowledge is necessary to attend an AED course.

At the end of this course, delegates will Cover:-

- signs and symptoms of various Heart conditions
- Treating an unconscious casualty
- CPR
- Treating an unconscious casualty utilising an AED
- Care, Maintenance and use of various AED devices



Delegates who successfully complete this course, including the practical assessments will receive a HSE approved certificate valid for one year.

Fire Safety Awareness



Fire Safety Awareness

At the end of this course, delegates will be able to demonstrate an understanding of;-

- The procedures to be followed in the event of fire
- How to call the fire service and liaise on site
- Identify which elements need to exist for fire to occur
- The three basic principles of fire extinction
- Identify the four classes of fire
- The principles and practice of fire risk assessment.
- Basic fire prevention.
- Arson prevention.
- Personal protection.
- Which measures are designed to prevent smoke travel and fire spread in a building
- The need for fire safety and how to implement measures to protect yourselves, colleagues and clients
- Use of correct fire equipment.
- Evacuation procedures and the control of personnel.



This course is practical and theoretical course is designed for personnel who require “initial” and/or “refresher” training in fire-fighting and evacuation techniques.

Fire Warden Training



Fire Warden/Marshall Training

This extremely popular course provides participants with a greater awareness and understanding of the threat posed by fire, their personal responsibility in preventing an outbreak and the action to be taken should a fire occur.

Delegates should develop:

confidence in carrying out your fire safety responsibilities
a greater awareness of the hazards of fire
an understanding of the nature of fire and how it spreads
knowledge of the threat fire poses to people and property
an understanding of why fire emergency procedures are implemented
the ability to distinguish between the different types of extinguishers and the fires for which they are suited
the ability to tackle small fires with confidence

This course is practical and theoretical course is designed for personnel who require “initial” and/or “refresher” training in fire-fighting and evacuation techniques.



This course will be of benefit to all staff, particularly those with a designated fire responsibility – fire warden/marshall – working in industry, commerce or the public sector.

Working Safely



Working Safely Course

The course provides grounding in the essentials of health and safety. Everyone at work should have an understanding of why they must work safely and this course offers exactly that. It introduces a new approach to health and safety training by the use of interactive exercises



At the end of this course, delegates will be able to demonstrate an understanding of:-

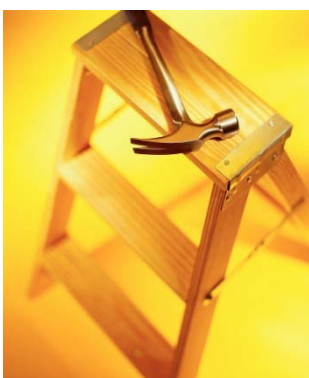
Introducing working safely – stresses the realities of human suffering behind the statistics and emphasises the importance of personal responsibility.

Defining hazard and risk – using familiar examples to define hazard and risk in every day language and show what can happen. Even simple or repetitive things can go wrong with serious consequences. Delegates are asked to think about hazards and risks they come across in their own work using 6 broad hazard groups.

Identifying common hazards – Use of clear examples to demonstrate the main issues such as entrances and exits, work traffic, fire, chemicals, electricity, physical and verbal abuse, bullying, stress, noise, slips, trips and falls, and manual handling.

Improving safety performance – This module deals with systems and processes and tries to bridge the gap between management and the workforce, encouraging the delegates to play a part in the processes that are commonly just seen as down to their line manager or supervisor. Also includes contract work, inspections, safe systems and permits, PPE, signage, emergency procedures, reporting and health checks.

Protecting our environment – a short introduction to waste and pollution focusing on how organisations and team members can get involved in reducing environmental impacts.

Managing Safety



Managing Safety Course

To enable delegates to understand health and safety legislation and its implication to them and their workplace so that they can manage and improve health and safety within their department.



At the end of this course, delegates will be able to demonstrate an understanding of:-

Safety Management– Applying basic management principles & practices to health and safety issues as part of a total management strategy. Setting achievable health and safety objectives and planning and implementing actions to achieve those objectives

Reactive monitoring – legal requirements for reporting and investigating accidents including techniques.

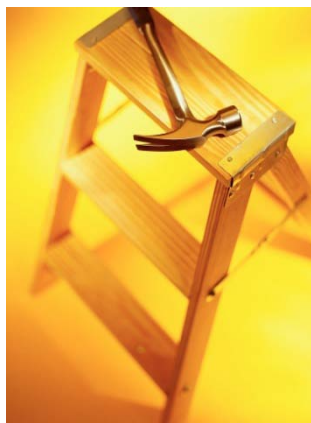
Risk assessment – identifying hazards, risks and applying control measures.

Active monitoring – methods of developing checklists, schedules and monitoring of data.

Review and audit

Health and safety legislation – sources of information, codes of practice and main provisions of legislation.

Workplace hazards - such as work equipment, housekeeping, noise, DSE, fire, chemical safety, ergonomics etc.
