3. Discounts may be made available to operators of scheduled services. Applications for discounts should be made in the first instance to the Business Development Manager; email: newbusiness@bca.aero
4. Applications for credit / account facilities must be made in writing to the Accounts Department.
5. Where credit facilities have not been arranged or accepted, by Belfast City Airport Limited, payment terms are cash or credit card before aircraft departure.
6. The PRM charge (Persons with Reduced Mobility) is set each year.
7. Fuel infrastructure fee included into-aircraft element.
8. In the event of the diversion of a passenger flight into Belfast City Airport, or a General Aviation Flight with zero departing passengers, the Passenger Load Supplement and Security Levy shall be applied to the arriving passengers and not the departing passengers.
9. Peak Time Departure Charge applies to departures with a scheduled time of departure (STD) or actual time of departure (ATD) between:
 - a. 06:30 and 09:00, Monday to Saturday
 - b. 09:00 and 10:30, Saturday and Sunday
 - c. 14:30 and 16:00, Daily excluding Saturday
